We are pleased to announce we are now accepting online payments! This new service is available online through our new "CSED Member Services Portal". Sign up today! It's quick and easy, just go online to

- 1. <u>https://my.alaska.gov</u>
- 2. From here choose <u>Register for</u> <u>a myAlaska Account</u>
- 3. Follow the steps to complete your registration
- 4. Once registration is complete, go back to myAlaska and choose <u>CSED Member Services</u> <u>Portal</u>
- Enter your member number and passphrase and proceed to the <u>member menu</u> where you can choose from options "<u>Payments</u>", "<u>Services</u>"_and "Settings"

From here you can choose <u>Payments</u> to make a one-time payment using your bank account, or a credit card.

Attention: You may make extra payments online using this option. However, this will not replace the withholding order to your employer. If you are interested in setting up recurring payments online, please contact us before setting it up.

Make a payment in person

If you are in Anchorage you can come to Window 7 at our customer service center and make a payment.

The hours for the cashier are **10:00** a.m. to **4:00** p.m. Mon—Wed, excluding State holidays.

- We are located across the street from the Atwood building in the first floor of the Linny Pacillo Parking Garage: 655 F Street, Anchorage AK 99501.
- Free visitor parking is available on the 2nd and 3rd floors of the Linny Pacillo parking garage.

Visitor parking is valid for 2 hours only. The security guard in the customer service lobby can validate your parking ticket.

Most Child Support collections come from employer garnishments

What is a withholding order?

A withholding order is sent to your employer and requires them to withhold wages every pay period to pay your child support. The payment may include past due child support.

What if I don't want to have wages deducted by my employer? Is there another way I can pay my child support?

CSED is federally mandated to send a withholding order when we are notified of an employer.

How soon after the employer receives the withholding order will the money come out of the my paycheck?

The employer will start taking out payments no later than the first pay period that occurs after the employer receives the withholding order. They will send the payment within seven days of deduction.

CSED Checklist:

- Always read and respond to mail from CSED.
- **Provide complete information** for faster processing and accurate orders.
- **Maintain contact.** A caseworker can give you updates on actions taken on your case.
- **Keep good records** of your dealings with CSED. Keep copies of your paystubs and tax records.
- Notify CSED of any changes to your address, new job, income, child support order, custody order by the court, or when a child turns 18.
- Check our website for more information, forms, and answers to questions.

DID YOU KNOW?

You can establish paternity at any time in your child's life. Your child will benefit from knowledge of who both parents are and have all the rights and privileges that both parents can provide.

Genetic Testing Information: You have an option to apply for paternity establishment only. Once case is set up, it will then be forwarded to the Paternity section who will contact the client to schedule genetic testing.
